NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Sikkim is hereby pleased to make the following rules further to amend the Sikkim State Mines and Geology Service Rules, 1996, namely,-

1. (1) These rules may be called the Sikkim State Mines and Geology Service (Amendment) Rules, 2020.
(2) They shall come into force at once.
2. In the Sikkim State Mines and Geology Service Rules, 1996, in Schedule-II,-
 - (i) against serial number 2, under the heading "Mining Engineering Wing" against the post of Joint Director (Mining), under the column "Eligibility Conditions", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the Senior Grade for at least 02 (two) years on substantive capacity";
 - (ii) against serial number 4, under the heading "Geological Wing" against the post of "Joint Director (Geology)", under the column "Eligibility Conditions", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the Senior Grade for at least 02 (two) years on substantive capacity";
 - (iii) against serial number 6, under the heading "Laboratory Technicians Wing" against the post of "Joint Director (Laboratory)", under the column "Eligibility Conditions", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the Senior Grade for at least 02 (two) years on substantive capacity";
 - (iv) against serial number 7, under the heading "Laboratory Technicians Wing" against the post of "Additional Director" under the column "Eligibility Conditions", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the Selection Grade-II for at least 02 (two) years on substantive capacity";
 - (v) in serial number 8, under the heading "Laboratory Technicians Wing" against the post of "Additional Director" under the column "Eligibility Conditions", for the clause (c), the following clause shall be substituted, namely:-

“(c) he/she should have worked in the Selection Grade-I for at least 02 (two) years on substantive capacity”;

(vi) in serial number 9, under the heading “Laboratory Technicians Wing”, against the post of “Principal Director”, under the column “Eligibility Conditions”. for the clause (c), the following clause shall be substituted, namely:-

“(c) he/she should have worked in the Supertime Grade-II for at least 02 (two) years on substantive capacity”;
