I am directed to say that it is proposed to fill up five (05) posts of Assistant Director (Disaster Management) in Level-10 in the Pay Matrix (pre-revised: PB-3, ₹15600-39100/-and Grade Pay ₹5400/-) in Disaster Management Division of Ministry of Home Affairs, in consultation with UPSC, on '20% by Composite Method {Deputation (including short-term Contract) plus promotion} and 80% by Deputation (including short-term contract)/ Absorption, failing which by direct recruitment' basis. The particulars of the post, eligibility conditions etc. are given in Annexure–I.

- 2. The pay of the selected officer will be regulated in accordance with the Department of Personnel & Training O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 as amended from time to time.
- 3. The maximum age limit for appointment on deputation (including short-term contract) shall be 56 years. Accordingly, the persons who will be crossing the age of 56 years, on the last date of receiving of applications as indicated in para-4 need not apply.
- 4. It is requested that wide publicity may be given to the vacancy circular amongst staff under your administrative control and, applications, in duplicate, in the enclosed proforma (Annexure-II) along with vigilance & cadre clearance, attested copies of certificates of educational qualification and attested copies of complete and up-to-date ACRs of last five years (with rubber stamp on each page) of the officers who can be spared in the event of their selection, may be sent to Under Secretary (Ad.V), Ministry of Home Affairs, Room No. 81-D, North Block, New Delhi-110001, within a period of 60 days from the date of publication of the vacancy circular in the Employment News. Applications received after the last date or without the copies of certificates of educational qualification and ACRs or otherwise found incomplete will not be considered. While forwarding the applications, it may also be verified and certified that the particulars furnished by the officers are correct and no disciplinary case is either pending or contemplated against him/her. The integrity of the Officer may also be certified during the last ten years.
 - 5. Incomplete applications and applications forwarded without set of essential documents as mentioned in para 4 above, shall be rejected. Candidates who apply for the post will not be allowed to withdraw their candidature subsequently.

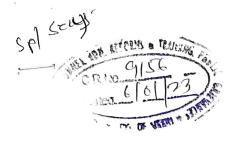
